Treasurer Report

Merry Christmas, Happy New Year and Happy Holidays,

As we close 2013, I'd like to thank departing board members Ed Sharpe and Silvia Lee for their contributions to our community. Ed has been on the board nearly as long (if not as long) as myself, and as the long term secretary he has spent countless hours recording the minutes of board meetings and helping us all remain compliant with California laws. Silvia joined the board recently, but her enthusiasm, commitment to a great neighborhood, and willingness to take on responsibilities such as the Bellringer are much appreciated. Thank you both for your service, I will miss seeing you every month and I look forward to seeing you in Belwood in the future.

Our financial picture is satisfactory, with expenses closely matching budget. In our December Board meeting, we voted to allocate \$50K from our checking account to our reserve accounts to pay for future expenses, which will give us roughly \$100K in reserve funds overall. While our reserves are not fully funded, we are working hard to make sure that money is there to pay for future expenses as they arise.

As you learned from the financial package, the board of directors is once again keeping dues flat at \$480 per unit. We last raised dues in 2012, but felt that we could maintain our financial condition without an increase this year. As previously stated, my goal has been to fully fund all operational items, and have the required annual reserve contribution, for each year's budget.

You will be billed for the 2014 assessment in December, and they will be due in January. By promptly paying, we will avoid spending money to continue to send statements to members, to send registered letters to those who are delinquent past certain time periods, and eliminating extra work by our bookkeeper. As always, if there is a reason why you can't pay your dues or need to schedule a payment plan, please feel free to contact myself or another board member to work out an appropriate arrangement for your personal situation.

Officers will be selected at the January board meeting. Thank you to all association members who cast their votes. Thank you to the board member candidates for volunteering.

Neighborhood Crime

Our neighborhood continues to be frequented by criminals. Below are some tips for your review.

Residents report incidents on **Nextdoor.com** and the town of Los Gatos uses **Nextdoor.com** to send notices to its members. It is recommended that you sign up and become a participant in **Nextdoor.com**.

TIPS

- Make your home look occupied, and make it difficult to break in.
- Lock all outside doors and windows before you leave the house or go to bed.
 Pushbutton locks on doorknobs are easy for burglars to open. Install deadbolt locks on all your outside doors. Secure patio doors. A steel or wooden rod in the guide will work. A pin type lock may also be used for added security.
- Keep your garage door closed and locked. Keep garage door openers out of sight or hidden in your car.
- Leave drapes and shades open. Closed drapes and shades indicate an unoccupied house.
- Leave lights on when you go out. If you are going to be away for a length of time, connect some lamps to automatic timers to turn them on in the evening and off during the day.
- Have adequate exterior lighting. A motion-sensitive light is recommended for backyards. s
- Install a surveillance cameras or install a security system.
- Have your lawn taken care of. Dry uncut grass says you are away.
- Trim trees and shrubs so that they cannot be used as hiding places for intruders.
- Don't allow daily deliveries of mail, newspapers or flyers build up while you are away. Arrange with the Post Office to hold your mail, or arrange for a friend or neighbor to take them regularly.
- Do not keep expensive jewelry at home unless you have a secure safe.
- Make an inventory of items in your home. Take photos of valuable items. Keep one copy and give a copy to your insurance company. Video tape the entire interior of your home showing your property.

Christmas Traditions

America is my adopted country and I very much love it here. But around Christmas time I am always getting sentimental and a bit homesick. I am from Germany, the Black Forrest to be precise, and there, the Christmas traditions are different than here in America.

While the tradition of gift giving to loved ones on Christmas is the same in both countries, in Germany, "Christkind", Christ's child, not Santa Claus, brings the gifts on Christmas Eve. When I grew up, the Christmas tree was put up on the 24th of December by my parents and the door to the living room was locked until the "Christkind" came and brought the presents. (Most German older houses are "not open floor plan" and each room has a door.) My mom would always cook a smoked ham shank for dinner, with potatoes and a green salad. After dinner a bell would ring, indicating that we were visited by the "Christkind". And when my brother and sister and I got older, we would go to Midnight Mass afterwards. There is something special about going to Mass at midnight. We would walk to church together surrounded by crisp, cold air and snow covered streets. In church, the smell of incense greeted you and the traditional Christmas songs, "Stille Nacht, Heilige Nacht", "Silent Night, Holy Night" or "Oh Tannenbaum" – "Oh Christmas Tree" transformed you in that magical Christmas spirit. There is something about these songs that to this day make me reminisce of childhood, excitement, warmth, family...

In the US, Christmas is celebrated with a visit from Santa Claus on Christmas eve. But is there a Santa Claus in Europe? Yes, there is. And Santa Claus has his own holiday. It is on December 6th, Saint Nicolaus Day.

How did Saint Nicolaus become Santa? Saint Nicolaus is believed to have lived in the 4th century A.D. in Myra what is now Turkey. He was a kind bishop and many legends surround him. One of the stories that I was told is that he saved three poor sisters by providing them with a dowry so that they could marry. While they were asleep, he would through gifts and coins through an open window. Over the course of many years, Nicholas's popularity spread and he became known as the protector of children and sailors. In Europe, traditionally, the children put their shoes or boots outside the front door on December 6th as soon as it is dark outside. They would then gather their boots before going to bed and would find sweet treats from Santa Claus.

Here in America, Saint Nicholas was first mentioned at the end of the 18th century. In December 1773, a New York newspaper reported that groups of Dutch families gathered to honor the anniversary of Saint Nickolas death (December 6th). The name Santa Claus evolved from Nick's Dutch nickname, Sinter Klaas, a shortened form of Sint Nikolaas (Dutch for Saint Nicholas). In the early 19th century stores began advertising Christmas shopping and soon newspapers crested separate sections for holiday advertisements, which often featured images of Santa Claus. The Salvation Army and yes, the Coca Cola company were instrumental in creating today's image of Saint Nick: the jolly, breaded man in a red suit. In the early 1890s, the Salvation Army needed money to pay for the free Christmas meals they provided to needy families. They dressed up unemployed men in Santa Claus suits and sent them into the streets of New York to solicit donations. In 1930, Coca Cola asked illustrator Haddon Sundblom to create Coca Cola advertising using jolly Santa Claus images.

What is my own family's tradition now? Our children, when they were younger, always put their boots outside the front door on December 6th for a visit from Saint Nicolaus, and for Christmas, we do a hybrid celebration - each of us picks one gift on Christmas eve and we open the rest of the gifts on Christmas morning followed by a big breakfast. We hang stockings but just for decoration since the boots were filled on December 6th. Because my husband's family lives in LA, we alternate celebrating Christmas at home and with his family in LA. There, they have their own Christmas traditions. Perhaps more on that next year...

Keep up the traditions or create your own, new traditions. But most of all enjoy time with family and friends this Holiday Season!
